

### 1 Accounting policies

These financial statements have been prepared in accordance with Financial Reporting Standard 102 Section 1A smaller entities- 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006 (as applicable to the small companies' regime).

These financial statements have been prepared using the historical cost convention except that as disclosed in the accounting policies certain items are shown at fair value.

Turnover comprises of fee income collected from member clubs.

The company is a mutual trading entity. Corporation tax is chargeable on investment income only.

Tangible assets are stated at cost less depreciation or impairment losses.

Depreciation is charged to write off the cost of assets over their estimated useful lives :

Fixtures and fittings	20% straight line
Computer equipment	33% straight line
Motor Vehicles	£5000 per annum

The value of the Trophies were revalued on 12th June 2024 by an independent valuer, C M Palmer.

Investments are stated at valuation.

Cash comprise cash in current bank account or on short term bank deposit account.
